Importer-Exporter Code (IEC)

Who needs an IEC ?

Any person or entity that imports or exports goods or from India needs an IEC, unless they are specifically exempted.

- ❖ Phone number of Directors
- ❖ Email id of Directors
- ❖ Cancelled cheque of Bank A/c of company

- ❖ Passport size photo of Directors
- ❖ Rental Agreement
- ❖ GST Registration of Company



Trade Mark Registration

Required Documents
